- Carports and Liability Insurance-Tami Redmond reported that quotes for insurance coverage

  are expected shortly.
- c. **Roof Leaks-**Tami Redmond reported that Building 4's flashing has been sealed and Building 5 is in the process of be assessed and will be finished in the next few weeks.
- d. **Palm Tree Trimming-**Rick Whitman reported that Jeremy from Melbourne Landscaping cannot do the trimming for six months. Tami Redmond indicated that she would request a quote from other vendors.
- e. **Gutter Cleaning-**Tami Redmond will request other quotes and plan to have this work done later in the year.

- a. New Monthly Assessment-Tami Redmond motioned to retain \$14,000 of the insurance refund in the Operating account, so that the adjusted Monthly Assessment for July thru December of 2024, will be \$150 per month (Compared to the current monthly fee of \$426), 2<sup>nd</sup> by Joanne Minchak and approved by all. Rick Whitman will have new coupon books ordered and mailed to all owners for the July 1<sup>st</sup> payment of \$150.
- b. **New Revised 2024 Budget-** Tami Redmond motioned to approve the revised 2024 Budget for July through December, which sets the Monthly Assessment at \$150, 2<sup>nd</sup> by Joanne Minchak and approved by all.
- c. **Dogs off Leashes-**Rick Whitman advised the residents to contact Animal Control if they see a dog off a leash.
