2. Old Business

- **A. Pool Resurfacing-** The pool resurfacing was rescheduled for October.

- b. Pool- Dan Osterhout is looking into switching the pool to a saltwater pool, it appears all that is needed is to put in a salt generator which is \$1300.
- c. Dario Nunez resignation- Dan Osterhout motioned to approved Darios resignation, Jim Petrino 2nd, all approved.
- d. Fines- With Muriel suspended from all committees, the fining committee needs an additional person, all fines currently on hold.
